Eligible Work:

Open to all PBWS members. working in watermedia; including watercolor, acrylic, gouache, casein, ink, gesso, watercolor pencils, crayons, sticks and pens. Collage, if used, must be completely of watermedia. No digital images, prints and other reproductions. Framed work must be glazed with Plexiglas. Works on other surfaces, if not framed must have wrapped edges, no staples showing, must be wired, taped and ready to hang. PLEASE, NO NUDES.

Art work must be original, not done under instruction, or copied from another artist's work. All reference photographs used must be original photographs taken by the artist. Submitted work must have been completed in the last three years. Paintings that have been exhibited in prior PBWS shows and exhibits are not eligible.

Entry Rules:

- All entries must remain hanging for the duration of the show.
- All entrants must sign disclaimer / waiver on the entry form.
- Entry fees are non-refundable if the artist fails to bring in the work or if the work submitted does not meet eligibility or is not juried in by the selection committee or juror.
- Armory will provide insurance for art work during the show. If the artist has a history of sales, the retail value and insurance value might be the same. Otherwise, the insurance value might be the costs that went into the work.
- 30% Commission to Armory; 10% Donation on sales to PBWS
- Size minimum is 16" x 20" and maximum is 40" x 40" (size includes frame)
- Palm Beach Watercolor Society reserves the right to photograph works for publicity and promotion.
- Work not picked up at designated date & time will be charged \$10/day storage fee.
